PSEG LONG ISLAND EXECUTIVE JOINS CHILDREN'S MUSEUM BOARD

GARDEN CITY, NY – Suzanne Brienza, Director of Revenue Operations at PSEG Long Island, has joined the Board of Trustees of the Long Island Children's Museum. Brienza, a resident of Farmingdale, NY, was elected to a three-year board term. The appointment was announced at the Museum's recent Annual Meeting,

In announcing the appointment, LICM President Suzanne LeBlanc said, "I can't think of anyone who better personifies the core values and mission of the Children's Museum. LICM's focus on diversity and inclusion issues will be strengthened by Suzanne Brienza's expertise in these areas."

In accepting the board position, Brienza pointed to the alignment of the Children's Museum's mission and values and her own professional and personal efforts. "As a member of PSEG Long Island's Diversity and Inclusion Council, I am very aware of the importance of embracing our differences," Brienza stated. "By doing so we grow stronger as a workforce and community. LICM brings together children from diverse backgrounds to be creative and play and in turn, embrace diversity. These are important lesson for our children," she added.

"As a parent, I have always admired Maya Angelou's quote, 'It is time for parents to teach young people early on that in diversity there is beauty and there is strength.' LICM provides opportunities for families to experience this first hand."

At PSEG Long Island, Brienza is responsible for Payment Processing; Credit and Collections; Customer Offices; Internal Controls; Revenue Reporting and Revenue Protection. She is the Executive Sponsor for the PSEG Long Island's Women's Network, a member of the PSEG Long Island Diversity and Inclusion Council and a member of the steering committee for the LIA's Women's Collaborative. Prior to joining PSEG in 2013, she held the position of Manager of LI Credit and Collections at National Grid.

Suzanne was a practicing attorney before joining National Grid. She holds a B.A. in English from Hofstra University and a J.D. from Touro College, Jacob D. Fuchsberg Law Center. She is a member of the New York State Bar Association.
